## Introduction to ECUPL

East China University of Political Science and Law (ECUPL) is one of the first higher legal education institutions founded in New China. With a comprehensive academic system spanning bachelor' s, master' s, and doctoral degrees, ECUPL has nurtured over 100,000 talents. It is among the first batch of Outstanding Legal Talent Training Bases designated by the Ministry of Education and is recognized as a key institution in Shanghai. Known as the “Oriental Pearl of Legal Education” . ECUPL is a multidisciplinary teaching and research-oriented university, primarily focused on legal studies, while also encompassing economics, management, and literature.

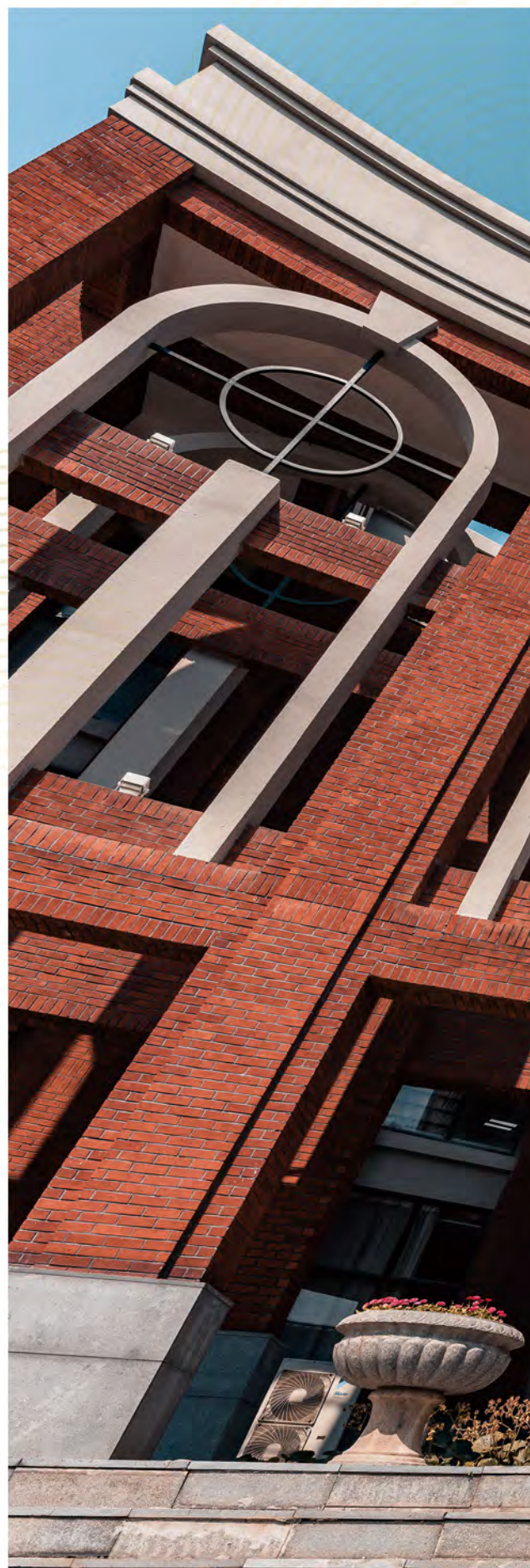
ECUPL has two campuses; in Changning and Songjiang, covering over 750,000 square meters. The university has 19 schools and departments and offers doctoral and master' s degree programs in Law as a first-level discipline, along with postdoctoral research stations. Additionally, ECUPL provides master' s degree programs in Political Science, Marxist Theory, Public Administration, and Applied Economics, as well as 24 doctoral programs, 52 master' s programs, and 26 undergraduate majors. In the 2012 national discipline evaluation, ECUPL' s Law program ranked among the top five in China, and in the 2016 evaluation, Law received an A rating, while Political Science received a B rating. The 2018 evaluation results for professional degree programs rated the Master of Law program as A and the Master of Public Administration as B. In 2018, ECUPL was selected as a high-level local university in Shanghai. In recent years, ECUPL has consistently ranked among the top three universities nationwide for core journal publications in law.



## ► PROGRAM INTRODUCTION

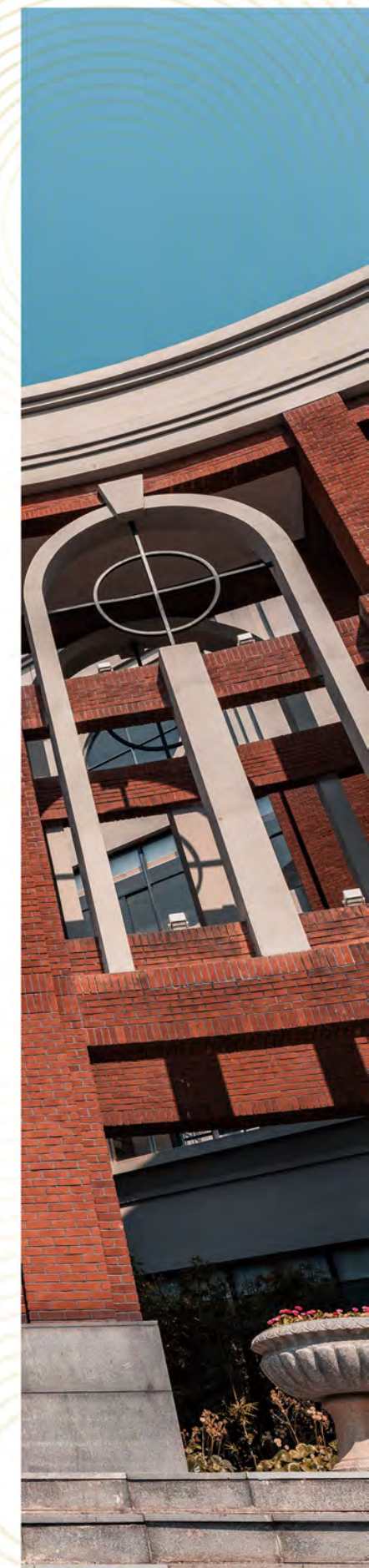
The undergraduate program in Law (International Business Law) is designed for international students. The program aims to cultivate professionals with strong academic research and practical skills, fluency in both Chinese and English, and cross-cultural communication capabilities.

This program is conducted entirely in English and spans four years. The first six semesters are dedicated to coursework, while the seventh and eighth semesters focus on internships and thesis writing.



## ► PROGRAM GOALS

- 1 Providing students with a solid foundation in the theory and practice of international business law and fostering their research abilities in law.
- 2 Cultivating students' ability to apply professional legal knowledge comprehensively, equipping them with independent legal practice skills and the ability to engage in legal cultural exchange.
- 3 Developing students' practical problem-solving skills for addressing real-world legal issues in international trade through flexible and diverse methods.
- 4 Teaching students basic Chinese communication skills, enabling them to achieve an elementary level of proficiency in Chinese.
- 5 Enhancing students' fundamental humanistic qualities and cross-cultural communication skills.





# ► CREDITS

## Credits

Students in this program must complete 126 credits to graduate. These include: 18 credits from required general education courses, 60 credits from required core courses, 15 credits from elective courses, and 33 credits from professional practice and thesis work.



## Social Practice

Students must participate in 16 weeks of social practice, which may include activities such as social surveys and practical work experience, to be completed before applying for the thesis defense. Social surveys conducted for thesis writing are counted as part of the social practice duration.

Social practice units primarily include businesses or non-profit organizations involved in Chinese language, commerce, and trade. A dedicated mentor must be assigned during the internship period. Social practice may be conducted domestically or abroad.

## Thesis

The graduation thesis adopts a mentorship system, with supervisors being either internal or external professional educators holding a doctoral degree or qualifications as postgraduate advisors, or experts from the business and trade sectors. Supervisors are fully responsible for overseeing the students' thesis work and must ensure sufficient time is allocated for guiding their students effectively.

## ► APPLICATION MATERIALS

- 1 Completed ECUPL Admission Application Form
- 2 A scanned copy of the applicant's passport and an ID photo.
- 3 A copy of the high school graduation certificate (or a pre-graduation certificate for current students).
- 4 A copy of transcripts for all completed courses.
- 5 Proof of language proficiency.
- 6 Two recommendation letters (for scholarship applicants).
- 7 A study plan of no less than 500 words.
- 8 A certificate of no criminal record.
- 9 Proof of financial support.
- 10 A medical examination report.

## ► ELIGIBILITY

Applicants must be in good physical and mental health, possess the required academic qualifications, and meet the language proficiency requirements.

- 1 Applicants must hold a high school diploma or equivalent to the Chinese high school level and be non-Chinese citizens with a valid foreign passport.

- 2 Language requirements:

For English-taught programs, applicants must have an IELTS score of 5.0, a TOEFL score of 60 or above, or pass an English interview conducted by telephone.

Applicants who completed their previous education in English-speaking regions with English as the teaching language, are generally exempt from providing English language certificates.

- 5 Self-funded students will receive admission notices and visa application forms between July and October.
